All that piece, parcel or lot of land, situate, lying and being on the Northeastern side of Meridian Avenue in a subdivision known as Super Highway Homesites, being known and designated as Lot No. 48 of said subdivision on a plat of same recorded in Plat Book P at page 53 and having according to said plat, the following courses and distances, to-wit:
