

**To All Whom These Presents May Concern:**

SEND GREETING:

Whereas, I , the said Mrs. Nellie B. Hannah  
 in and by my certain promissory note in writing, of even date with these  
 Presents, I am well and truly indebted to Bank of Piedmont  
 in the full and just sum of (\$446.41) Four Hundred Forty-six and 41/100  
 , to be paid Payable one year from date

, with interest thereon from maturity  
 at the rate of 6 per centum per annum, to be computed and paid in advance  
 until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
 the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
 may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the  
 hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof  
 necessary for the protection of his interests to place and the holder should place the said note or this mortgage  
 in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises  
 to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to  
 the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, that I , the said Mrs. Nellie B. Hannah  
 , in consideration of the said debt and  
 sum of money aforesaid, and for the better securing the payment thereof to the said Bank of Piedmont  
 according to the terms of the said note, and also in  
 consideration of the further sum of Three Dollars, to me , the said Mrs. Nellie B. Hannah  
 , in hand well and truly paid by the said Bank of Piedmont  
 at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bar-  
 gained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Bank of  
 Piedmont, its successors and assigns forever;

All that piece, parcel or lot of land in Grove Township, Greenville County, State  
 of South Carolina, containing one and two-one hundredths (.2/100) acres more or  
 less, having the following metes and bounds:

Beginning at iron pin corner of Ralph Turner lot, thence along line of Ralph Turner  
 S-63 1/4 E 2 chains 31 links to iron pin, thence S 22- 1/2 W 2 chains 90 links to  
 iron pin center of road, thence N 74 3/4 W 3.00 chains to iron pin, thence N 16 3/4 E  
 1 chain 49 links to iron pin thence N 26 1/4 E 2 chains 16 links to the beginning  
 corner.

This is the same tract of land conveyed to J. H. Loooper by deed of Grady C. Reeves  
 and dated the 6th day of November, 1946 and recorded in office for Greenville County  
 in Volume 302, page 153, and subject to deduction of the lot sold to Mrs. Katherine  
 T. Reeves, May 6th, 1947.
