NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Broad Street in the City of Greenville, being shown as Lot No. 1 on the plat of property of C. F. Putman made by C. O. Riddle in July, 1953, and described as follows:

"BEGINNING at a stake on the southern side of Broad Street 240.5 feet east from Fall Street at the corner of property of Addie A. Griffin Estate and running thence with the line of said property S. 18-36 W. 160.5 feet to a stake on an alley; thence with the northern side of said alley S. 70-12 E. 35.75 feet to a stake at the corner of Lot 2; thence with the line of said lot N. 18-36 E. 161.3 feet to a stake on Broad Street; thence with the southern side of said street N. 71-30 W. 35.75 feet to the beginning corner."
