foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor(s) agrees to pay all costs and expenses including a reasonable amount as attorneys' fees, this to be added to

the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All of that parcel or lot of land in Chick Springs Township of Greenville County, State of South Carolina, located near Pleasant Grove Baptist Church and about two miles southeast of the City of Greer, lying east from the old Greenville - Spartanburg Road and on the west side of a new street, designated as Lot No. 27 on a plat of property entitled J.M.
