WE, Garnet Burton, Dora F. Burton, James A. Burton & Edna L. Burton SEND GREETING:

WHEREAS, we the said Garnet Burton, Dora F. Burton, James A. Burton & Edna L. Burton in and by our certain promissory note in writing of even date with these Presents, are well

and truly indebted unto the Crrizens Building and Loan Association, Greer, S. C., in the full and just sum of

Three Thousand & no/100 - - - - - - - (\$ 3000.00) Dollars,

with interest from the date hereof at the rate of seven per cent (7 %) per annum, unpaid interest to

bear interest at the same rate, to be repaid in installments of

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oaklawn Township, on the West side of U. S. Highway No. 29, and known and designated as lots nos. 22, 23, 24 and 25 of the T. D. Bennett Sub-Division as shown by plat made by G. Sam Lowe, Registered C. E. dated August 24, 1948 and recorded in the R. M. C. Office for Greenville County, in Plat Book S page 143, reference to said plat will furnish complete details as to courses and distances.
