All that certain piece, parcel, or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as the rear portion of Lot No. 47 of a subdivision known as Junction Heights, as shown on plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book C, at Page 106, and having the following metes and bounds, to-wit:
