"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **on the Southeastern side of A Street, near the City of Greenville, Greenville Township, being shown and designated a Lot 178 of Section 1 of plat of F. W. Poe Manufacturing Company, recorded in Plat Book Y at page 281 and according to said plat having the following metes and bounds, to-wit:**

BEGINNING at an iron pin on the Southeast side of A Street at the joint front corner of Lots 177 and 178 and running thence with the line of Lot 177 S. 41-10 E. 86.2 feet to pin; thence N. 48-54 E. 56.2 feet to an iron pin; thence N. 41-11 W. 86.3 feet to an iron pin on A Street; thence with the Southeast side of A Street, S. 48-50 W. 56.1 feet to the point of beginning.
