All our right title and interest in and to all that piece, parcel or lot of land situate, lying and being in the Town of Travelers Rest, Bates Township, State and County aforesaid, on the east side of U. S. Highway No. 25, and being Lot 3 on plat of property of W. Smith Batson, Jr. prepared by W. J. Riddle, July 1947, and having, according to said Plat, the following metes and bounds, to-wit:
