I, Arthur McAllister,
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Thousand Five Hundred and No/100 - - -

DOLLARS (\$ 5,500.00), with interest thereon from date at the rate of five and one-half per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Gantt Township, on the Western side of Burty Road, and having, according to Plat of property of Arthur McAllister made by Dalton & Neves in May 1957, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Burty Road, at the corner of property now or formerly owned by Dale Sellers, and running thence with line of said property, S. 82-30 W. 227.1 feet to an iron pin in line of other property of the Mortgagor; thence with the line of said property, N. 21 E. 207.2 feet to an iron pin; thence continuing with line of other property of the Mortgagor, S. 72-39 E. 200 feet to an iron pin on Burty Road; thence with the Western side of Burty Road, S. 21 W. 111.2 feet to the point of beginning.
