ALL that lot of land in Chick Springs Township, Greenville County, State of South Carolina, on the Northwestern side of Mable Avenue, being shown as Lot No. 31 on Plat No. 2 of the property of James M. Edwards in May, 1953, recorded in the R.M.C. Office for Greenville County in Plat Book EE at page 60, and having according to said plat, the following metes and bounds, to-wit:
