NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of the Dunham Bridge Road, near the City of Greenville, being shown as Lot No. 8 on plat of the property of Thomas Clifton Collins, made by W. J. Riddle, Surveyor, in August 1945, and described as follows:

BEGINNING at a stake on the eastern side of the Dunham Bridge Road 252 feet south from the Easley Brige Road at corner of Lot No. 7, and running thence with the line of said lot S. 48-25 E. 478.2 feet to a stake; thence S. 15-56 W. 76.9 feet to a stake corner of Lot No. 9; thence with the line of said lot N. 49-56 W. 491.8 feet to a stake on the Dunham Bridge Road; thence with the eastern side of the Dunham Bridge Road N. 27-56 E. 84 feet to the beginning corner.

Being the same premises conveyed to the mortgagor by deed recorded in Deed Book 305 at Page 121.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
