

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain parcel or lot of land situated on the north side of West Poinsett Street in the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, designated as Lot # 5, of the R. L. Ford property, and having the following courses and distances, to wit:

BEGINNING at an iron pin on the north side of West Poinsett Street corner of lots # 5, 6, and running thence along line of same, N. 8-27 E. 181½ feet to an iron pin on line of Lot # 7, S. 87-50 W. 70 feet to an iron pin corner of lot # 4; thence along line of Lot # 4, S. 8-27 W. 181½ feet to an iron pin edge of West Poinsett Street, thence along said Street N. 87-50 E. 70 feet to the beginning corner.
