----(herein called mortgagor) SEND GREETING: WHEREAS, the said mortgagor Mary D. Neild in and by a certain promissory note in writing, of even date with these Presents is well and truly indebted to the LIBERTY LIFE INSURANCE COMPANY, a corporation chartered under the laws of the State of South Carolina, in the full and just sum of Fourteen Thousand and No/100- ---(\$ 14,000,00) DOLLARS, to be paid at its Home Office in Greenville, S.
