WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Five Thousand Six Hundred and No/100ths-----  
DOLLARS (\$ 5,600.00 ), with interest thereon from date at the rate of SIX-----  
per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lot No. 20, as shown on a plat entitled "Property of Leslie & Shaw, Inc." prepared by C.C. Jones & Associates, dated February 1957, and recorded in the R.M.C. Office for Greenville County in Plat Book NN at page 3, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Morris Street at the joint front corner of Lots Nos. 19 and 20, and running thence with the joint line of said lots S. 4-26 W. 100 feet to the joint corner of Lots Nos. 19, 20 and 21; thence with the joint line of Lots Nos. 20 and 21, S. 85-34 E. 110 feet to an iron pin on the Western side of Nuggat Street at the joint front corner of Lots Nos. 20 and 21; thence with the Western side of Nuggat Street N. 4-26 E. 85 feet to an iron pin at the Southwest intersection of Nuggat and Morris Streets; thence with the curve of the intersection of Nuggat and Morris Streets (the chord of which is N. 40-34 W. 21.3 feet) to an iron pin on the Southern side of Morris Street; thence with the Southern side of Morris Street N. 85-34 W. 95 feet to the point of beginning.
