SEND GREETING:

Whereas, I, the said Rowena C. Hatcher
in and by my certain real estate note in writing, of even date with these
Presents, as well and truly indebted to First National Bank of Greer
in the full and just sum of Seven Hundred Fifty and NO/100
, to be paid August 1, 1958, in one entire installment

, with interest thereon from maturity
at the rate of -7- per centum per annum, to be computed and paid monthly
until paid in full; all interest not paid when due to bear
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof
necessary for the protection of his interests to place and the holder should place the said note or this mortgage

of Greer, on the West side of Piedmont Avenue (now called Memorial Drive), identified

September, 1935, and having the following metes and bounds:
