C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, in the City of Greer, designated as Lot No. 25 of the Westmoreland Circle, according to amended plat by H. S. Brockman, Surveyor,

dated July 21, 1938, and having the following courses and distances, to wit:-

BEGINNING at an iron pin, corner of Lot #24 and running with Pine Street N 17-40 E 60 feet to iron pin, corner of Lot #26; thence along line of Lot #26 N 72-20 W 150 feet to an iron pin; thence S 17-40 W 60 feet to iron pin, corner of Lot #24 thence along line of Lot #24 S 72-20 E 150 feet to the beginning corner.
