AND IT IS FURTHER AGREED AND COVENANTED, by and between the said parties, that until the debt hereby secured be paid, the mortgager, his lists, executors, administrators or assigns, shall and will pay all taxes; paying assessments, water rents and other liens on the property hereby mortgaged, when due and payable; and in case they fail to do so, the said mortgages, its successors or assigns, may pay said taxes, paving assessments, water rents or other liens, together with any costs or penalties incurred thereon, or any part thereof, and reimburse itself for the same, together with interest on the amount so paid, at the rate of six (6%) per cent per pum, from the date of such payment, which said sum shall be secured by this mortgage, and included in any judgment recovered hereunder.

PROVIDED ALWAYS, NEVERTHELESS, and it is the true intent and meaning of the parties to these Presents, that if the Mortgagor, do and shall well and truly pay, or cause to be paid, unto the said PALMETTO STATE LIFE INSURANCE COMPANY, its successors or assigns, the said debt or sum of money, aforesaid, with the interest thereon, if any shall be due, according to the true intent and meaning of the said note and all sums of money provided to be paid by the Mortgagor, his heirs, executors, administrators or assigns, together with the interest thereon, if any shall be due, under the covenants of this mortgage, then this deed or bargain and sale shall cease, determine and be utterly null and void; otherwise it shall remain in full force and virtue.

AND IT IS AGREED, by and between the said parties, that, should legal proceedings be instituted for the collection of the debt secured hereby, then and in that event, the said mortgagee, PALMETTO STATE LIFE IN-SURANCE COMPANY, its successors or assigns, shall have the right to have a Receiver appointed of the rents and profits of the above described premises, with power to forthwith lease out the said premises anew if he should so elect, who, after deducting all charges and expenses attending such proceedings, and the execution of the said trust as Receiver, shall apply the residue of the said rents and profits towards the payment of the debt secured hereby.

AND IT IS FURTHER AGREED AND COVENANTED by and between the said parties, that in case the debt secured by this mortgage, or any part thereof, is collected by suit or action, or this mortgage be foreclosed, or put into the hands of an attorney for collection, suit, action or foreclosure, the mortgagor ,his heirs, executors, administrators or assigns, shall be chargeable with all costs of collection, including ten (10%) per cent of the principal and interest on the amount involved as attorney's fees, which shall be due and payable at once, which

charges and fees, together with all costs and expenses, are hereby secured, and may be recovered in any suit or action hereupon or hereunder. And it is agreed, that in the event the mortgagee or holder hereof should become a party to any suit involving this mortgage or the title to the premises herein described, the mortgagor, his heirs, executors, administrators or assigns shall also pay a reasonable attorney's fee to the attorney for the mortgagee or holder.
