BEGINNING at an iron pin on the Northern side of Lakemont Drive, joint front corner of Lots 8 and 9, and running thence with the line of Lot 9, N. 15-08 E. 176.7 feet to an iron pin; thence N. 74-58 W. 160 feet to an iron pin at rear corner of Lot 6; thence with line of Lot 6, S. 14-08 W. 174.9 feet to an iron pin on Lakemont Drive; thence with the Northern side of Lakemont Drive, S. 74-10 E. 160 feet to the point of beginning.
