"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as lot #18 on plat of property of Elizabeth E. Voyles, said plat being recorded in Plat Book Y at Page 73, in the R.M.C. Office for Greenville County and described as follows:

"BEGINNING at an iron pin on the South side of Echols Drive, joint front corner of lots #17 and 18, and running thence with the line of lot #17, S. 21-42 E. 111.4 feet to iron pin; thence S. 68-18 W. 90 feet to an iron pin, joint rear corner of lots #18 and 19; thence with line of lot #19, N. 21-42 W. 111.4 feet to an iron pin on the SOTH side of Echols Drive; thence with said Drive, N. 68-18 E. 90 feet to the point of beginning."
