NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the Northeast side of Seminole Drive, and being known and designated as Lot No. 47 of Sunset Hills on Plat made by R. E. Dalton, December 1945, recorded in Plat Book P, at page 19, and having the following metes and bounds:

BEGINNING at an iron pin on the Northeast side of Seminole Drive, front corner of Lots Nos. 47 and 48, and running thence with the line of Lot No. 48, N. 48-50 E. 175 feet to an iron pin on the Southwest side of a 5-foot strip reserved for utilities; thence with said strip, N. 41-10 W. 75 feet to an iron pin; thence with the line of Lot No. 46, S. 48-50 W. 175 feet to an iron pin; thence with Seminole Drive, S. 41-10 E. 75 feet to the beginning.
