## MORTGAGE

STATE OF SOUTH CAROLINA, COUNTY OF GREENVILLE

WHEREAS: I, Ernest W. Bryant, Jr.

Greenville, South Carolina , hereinafter called the Mortgagor, is indebted to H. V. Higley , as Administrator of Veterans' Affairs, an Officer of the United States of America, and his successors in such office, as such, and his or their assigns, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Ninety-Four Hundred and No/100- - - -

Dollars (\$9400.00 ), with interest from date at the rate of Four & One-Halfper centum ( 4 %) per annum until paid, said principal and interest being payable at the office of the Loan Guaranty Officer, Veterans Administration Regional Office, at Columbia, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Fifty-Two and 25/100- -Dollars ), commencing on the day of 19 58, (\$ 52.25 January llth and continuing on the day of each month thereafter until the principal and interest llth are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the , 19 82. 11thday of December

Now, Know All Men, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, and unto his successors in such office, as such, and his or their assigns, the following described property, to-wit:

All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, in Gantt Township, on the Northern side of Echols Drive, being shown as lot #7, on a plat of Elizabeth E. Voyles, recorded in Plat Book Y at Page 73, and described as follows:

BEGINNING at a stake on the Northern side of Echols Drive, 686.8 feet East from Augusta Road, at corner of lot #6, and running thence with the line of said lot, N. 21-42 W. 115 feet to a stake; thence N. 68-18 E. 100 feet to a stake at corner of lot #8; thence with the line of said lot, S. 21-42 E. 115 feet to a stake on Echols Drive; thence with the Northern side of said Drive, S. 68-18 W. 100 feet to the beginning corner.

Being the same premises conveyed to the mortgagor by H. S. Haynes by deed to be recorded.
