We, **J. H. Brown and Pauline Brown of Greenville County** SEND GREETING:

Whereas, **we**, the said **J.H. Brown and Pauline Brown**  
in and by our certain **Promissory** note in writing, of even date with these  
Presents, are well and truly indebted to **The Pelzer-Williamston Bank**  
in the full and just sum of **Twelve hundred twenty-one and 77/100 - - - (1221.77) - - -**  
**- - -Dollars - - -**, to be paid **on demand after date**

, with interest thereon from **date**  
at the rate of **6** per centum per annum, to be computed and paid **semi-annually**  
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land in **Grove Township, Greenville County, State of South Carolina**, on the west side of the **Augusta Road**, containing **8.36 acres**, more or less, and more particularly described as follows:

BEGINNING at an iron pin in the middle of said **Augusta Road**, corner **Waldrop Property**, and running thence along middle of said road **S. 7-35 W.**, 1361 feet to bend in said road; thence still along middle of said road, **S. 4-05 W.** 100 feet. thence **S. 59 W.** 254.3 feet to iron pin in middle of **Old Augusta Road**; thence along middle of **Old Augusta Road**, **N. 32-35 W.** 232 feet to stake; thence **N. 15-23 E.** along line of **Rogers Estate property**, 1450 feet to iron pin; thence **S. 75-30 E.** 128.5 feet to the point of beginning in middle of **Augusta Road**, and being the same tract of land conveyed to me by **Polly Peterson** by deed dated **May 19, 1947**, recorded in the **R.
