I, **LELAND D. HELLMAN** of **Greenville, South Carolina**, hereinafter called the Mortgagor, send (s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

All that lot of land in the County of Greenville, State of South Carolina, known and designated as Lot No. 167 on plat of AUGUSTA ACRES subdivision recorded in Plat Book S, page 201 of the R.M.C. Office for Greenville County, S. C., said lot having a frontage of 100 feet on the south side of Meadors Avenue, a depth of 242.6 feet on the eastern side, a depth of 233.7 feet on the western side and a rear width of 100.4 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
