Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained. sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville State of South Carolina:

All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, lying on the Southwest side of Cool Springs Drive, in the City of Greenville, being shown as lot # 38, on a plat of North Meadow Heights, recorded in Plat Book W at Page 183, and being more particularly described according to a plat of the property of M. B. Bridges, Jr., prepared by J. C. Hill, dated February 19, 1958, as follows:

BEGINNING at an iron pin on the Southwest side of Cool Springs Drive, front corner of lot #37, which pin is 191.5 feet Southeast from the intersection of said drive with Wedgewood Drive and running thence with the Southwest side of Cool Springs Drive, S. 38-51 E. 70 feet to an iron pin, front corner of lot # 39; thence with the line of said lot, S. 49-28 W. 160 feet to an iron pin; thence N. 39-55 W. 89 feet to an iron pin, rear corner of lot # 37; thence with the line of said lot, N. 56-12 E. 162.6 feet to the beginning corner.
