WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF

GREENVILLE, in the full and just sum of Five Thousand, one hundred & no/100 (\$ 5, 100.00) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

Thirty-Eight and 67/100 - - - - - - (\$38.67) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. "BEGINNING at an iron pin on the Southwestern side of Fairlane Circle, joint front corner of Lots Nos. 30 and 31 and running thence with the joint line of said lots S. 58-11 W. 155 feet to an iron pin in the line of lot No. 29; thence with the line of Lot No. 29 N. 31-49 W. 75 feet to an iron pin on the Southern side of Henderson Drive; thence with Henderson Drive N. 58-11 E. 130 feet to an iron pin; thence continuing with Henderson Drive as it intersects with Fairlane Circle, following the curvature thereof, the chord of which being S. 76-49 E. 35.5 feet to an iron pin on Fairlane Circle; thence with Fairlane Circle S. 31-49 E. 50 feet to the beginning corner.
