(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

DOLLARS (\$ 1,000.00---), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the northern side of the New Belt Highway, formerly known as Old Farr's Bridge Road, said lot being shown as Lot No. 6 on the New County Block Book, Section 5, Page 149, and being more particularly described as follows:

Beginning at an iron pin on the northern side of the Belt Highway, corner of Lot No. 5, and running thence with line of said lot in a northerly direction 75 feet, more or less, to pin in line of Lot No. 8; thence with line of said lot in a northwesterly direction 75 feet, more or less, to iron pin, corner of Lot No. 7; thence with line of said lot, in a southeasterly direction, 88 feet, more or less, to iron pin on the Belt Highway; thence with the northern side of said Highway in an easterly direction 75 feet to the point of beginning; said premises being the same conveyed to the mortgagor by Donna May Wilson McAtee, William Wilson and Jas. F. Wilson by deed dated April, 1929, recorded in the RMC Office for Greenville County in Volume 148 at page 84.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
