to be paid Seventy nine hundred twenty - - - - - DOLLARS,

as follows: \$792.00 on March 12th of each year hereafter until March 12, 1968, at which time the entire balance shall become due and payable with the privilege of increasing the payments on any interest payment date. with interest thereon from date in advance the rate of 6 per centum per annum, to be computed and paid semi-annually until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor(s) agrees to pay all costs and expenses including a reasonable amount as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land in Chick Springs Township, State and county aforesaid, about one mile West from Greer, on the South side of the Super Highway # 29, and having the following courses and distances, to-wit:

BEGINNING on Park Avenue on corner of Lot #48 (iron pin on stake the corner), and runs thence with the line of Lots 48,47 and 46 on plat hereafter referred to, S. 78E. 195 feet to joint corner of Lots 46 and 45; thence N. 12 E. 114 feet to a stake, corner of Lot #23; thence along the line of Lot #23 to a stake on the East side of Park Avenue; thence along the eastern edge of Park Avenue in a southerly direction 140 feet to the beginning, and being all of lots #21 and #22 on a plat of the Estate of W.H.
