I, D. B. EVANS of
Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

AIKEN LOAN & SECURITY COMPANY

, a corporation organized and existing under the laws of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Eleven Thousand Nine Hundred Fifty Dollars (\$11,950.00), with interest from date at the rate of five & one-fourth per centum (5 1/4%) per annum until paid, said principal and interest being payable at the office of Aiken Loan & Security Company in Florence, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Seventy-one and 70/100 ----- Dollars (\$ 71.70), commencing on the first day of May, 19 58, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of April, 19 83.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that lot of land in the County of Greenville, State of South Carolina, at the northwest corner of Cardinal and Runyon Drives, being the southern portion of Lots Nos. 13 and 14 on plat of PINE BROCK EXTENSION, recorded in Plat Book W, page 73 of the R.M.C. Office for Greenville County, S. C., and having according to said plat and a recent survey made by R. E. Dalton, R. E., February 1958, the following metes and bounds, courses and distances, to wit:

BEGINNING at an iron pin on the northeast side of Cardinal Drive, which pin is 75 feet northwest from the northwest corner of Cardinal Drive and Runyon Drive; thence with the northeast side of Cardinal Drive, S. 25-50 E. 65.7 feet to an iron pin; thence with the curve of said Cardinal Drive as it intersects with Runyon Drive, the chord of which is S. 68-50 E. 13.6 feet to an iron pin on the northwest side of said Runyon Drive; thence with the northwest side of said Runyon Drive N. 68-09 E. 140.7 feet to an iron pin; thence N. 25-50 W. 75 feet to an iron pin; thence with a new line through Lots Nos. 14 and 13, S. 68-09 W. 150 feet to the beginning corner.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.
