The Additional Electric Transmission Lines of the Company (including but not limited to lines described in the Mortgage and in the First, Second, Third and Fourth Supplemental Indentures thereto and which are now subject to the lien of the Mortgage, as supplemented, in which changes in voltage and other changes have been made), including the towers, poles, wires, switch racks, insulators and other appliances and equipment and all other property, real, personal or mixed, forming a part thereof or appertaining thereto, together with all the rights of way, easements, permits, privileges, licenses, consents and rights for or relating to the construction, maintenance, or operation thereof, through, over, under or upon any public streets or highways or other lands, public or private, including, but not limited to, the following described transmission lines:

(174) The Yanceyville 132 KV single-circuit transmission line extending from the Company's Roxboro-Danville 132 KV Line near
