AND We do hereby bind myself and my Heirs, Executors and Administrators, to warrant and forever defend all and singular the said Premises unto the said R. S. DeLoach, his Heirs and Assigns, from and against us and our

Heirs, Executors, Administrators and Assigns lawfully claiming, or to claim the same, or any part thereof.

AND it is agreed by and between the said parties that in case of default in any of the payments of interest or principal as herein provided for, the whole amount of the debt secured by this mortgage shall become due and payable at once.

AND IT IS FURTHER AGREED, by and between the said parties, that the said Frank H. & Grace J. DeBusk, their

Heirs, Executors or Administrators, shall and will insure the house and buildings on said lot, and keep the same insured from loss or damage by fire, and assign the Policy of Insurance to the said R. S. DeLoach

and in case that We or our heirs shall, at any time, neglect or fail so to do, then the said R. S. DeLoach

may cause the same to be insured in his name, and reimburse himself for the premium and expenses of such insurance, together with interest on the amount so paid, at the rate of Six (6%) per cent. per annum, from the date of such payment, under this Mortgage.
