BEGINNING at an iron pin on the East side of Proffitt Drive, front corner of Lots Nos. 26 and 27; thence with the line of said lots, S. 89-17 E. 189.5 feet to an iron pin; thence S. 6 E. 86.3 feet to an iron pin; thence with the line of Lots Nos. 29 and 28, S. 83-45 W. 200.4 feet to an iron pin on said Drive; thence with said Drive, N. 0-43 E. 105 feet to the beginning.
