Whereas, I, the said S.B. Fleming
in and by my certain promissory note in writing, of even date with these
Presents, am well and truly indebted to B.P. Edwards
in the full and just sum of Four thousand nine hundred forty-seven and 82/100-
(4,947.82)- - -, to be paid \$75.00 per month for 47 months, all to be
due and paid in full in 48 months from date hereof--

, with interest thereon from date hereof--

at the rate of seven ⁷per centum per annum, to be computed and paid annually from date hereof
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof
necessary for the protection of his interests to place and the holder should place the said note or this mortgage
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to

Highway and Piedmont and Northern Railway, at Old Camp Sevier, in
Greenville County, State of South Carolina, known as a part of the E.
M. Wharton Property, and designated as Lots 59 and 60 on a plat made
for him by R. E. Dalton, dated June, 1917, which plat is recited to be
recorded in Plat Book 'E' at page 53, but in fact is recorded in Book
'F' at page 208,. The said lots fronting on Wood Avenue, and being
the same lots conveyed to C. O. Hobbs To Will N. Ayers ~~XXXXXXXXXXXX~~
~~xx~~ by deed recorded in Book 87, at page 536, and by Will N. Ayers to
Roscoe Ayers by deed recorded in Book 114 at page 102; and being the
same lots conveyed to S. B. Fleming by Roscoe Ayers by deed recorded
