To All Whom These Presents May Concern:

We, Edmund E. Ware, Jr. and Addie Lou Ware, of Greenville County

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF

GREENVILLE, in the full and just sum of Nine Thousand and No-100 - - - - (\$9,000.00 - -) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of Si xty-Three

extended, will be due and payable 20 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville lying North of the White Horse Road and having according to a survey prepared for Edmund E. Ware, Jr. and Addie Lou Ware by J. C. Hill (LS) dated March 5, 1958 the following metes and bounds to-wit:

BEGINNING at a point in the center of an un-named road which point is 190 feet Northeast of the center of the intersection of said un-named road with the White Horse Road, and running thence with the center of said un-named road N.57-51 E. 360 feet to a point in line with other property owned by Ware; thence with said line N. 24-15 W. 250 feet to an iron pin in the line of property now or formerly known as Smoak; thence with Smoak's line S. 57-51 W. 360 feet to an iron pin; thence S. 24-15 E. 250 feet to the point of beginning; the Southern end of the property is subject to a 26 foot easement or deed given to Greenville County for road purposes; and being a portion of the same property conveyed to the mortgagors by E. E. Ware by deed dated January 28, 1949 and recorded in the R.M.C. Office for Greenville County in Deed Volume 373 at Page 221.
