WHEREAS, the Mortgagor is well and truly indebted unto

, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Sixteen Thousand Six Hundred Dollars (\$ 16,600.00 ), with interest from date at the rate of Five & one-fourth per centum ( 5 1/4 %) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Ninety-nine and 60/100----- Dollars (\$ 99.60 ), commencing on the first day of June, 1958, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of May, 19 83.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that lot of land with the buildings and improvements thereon, situate on the East side of Lake Fairfield Drive, near the City of Greenville, in Greenville County, South Carolina, being shown as a portion of Lot 21 on Plat of Section 1, of Lake Forest, recorded in the RMC Office for Greenville County, S. C., in Plat Book GG, page 17, and also a portion of property of E. D. Cobb adjacent thereto, and having according to a survey made by R. K. Campbell, April 23, 1958, the following metes and bounds, to wit:

BEGINNING at an iron pin on the East side of Lake Fairfield Drive at joint front corner of Lots 21 and 22 as shown on plat of Section 1, Lake Forest, above mentioned, and running thence with the line of Lot 22, N. 69-38 E., 130 feet to an iron pin; thence N. 15-33 E., 84 feet to an iron pin; thence S. 79-33 W., 191.0 feet to an iron pin on the East side of Lake Fairfield Drive; thence with Lake Fairfield Drive, S. 29-09 E., 101.7 feet to the beginning corner.
