"All that certain piece, parabologist of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, shown as Lots 16, 17, 18 19 and 20 and parts of Lots 9, 10 and 11 of Block D as shown on plat of Fair Heights, recorded in Plat Book F at page 257 and when described as a whole, has the following metes and bounds:
