NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

near the City of Greenville, on the Eastern corner of Sumter Street and Newberry Street (formerly Nancy Drive, formerly Hampton Street), being shown as Lot No. 32 on Plat of property of Central Realty Corporation recorded in Plat Book S, at page 110, and described as follows:

BEGINNING at a stake at the Eastern corner of Sumter Street and Newberry Street, and running thence with the Northeastern side of Newberry Street, S. 25-00 E. 60 feet to a stake at the corner of Lot No. 31; thence with the line of said lot, N. 65-00 E. 205 feet to a stake; thence N. 25-00 W. 129.6 feet to a stake on Sumter Street; thence with the Southeastern side of said Street, S. 46-06 W. 216.2 feet to the beginning corner.
