"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 18, Section 2 of Judson Mills Village, recorded in Plat. Book K, Page 25, in the R. M. C. Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Fourth Avenue at the joint front corner of Lots 18 and 19 of Section 2 and running thence with the line of Lot 19 S. 83-53 E. 122 feet to an iron pin; thence S. 6-07 W. 80 feet to an iron pin at joint rear corner of Lots 17 and 18; thence with the line of Lot 17 N. 83-53 W. 122 feet to an iron pin on Fourth Avenue; thence with said Fourth Avenue N. 6-07 E. 80 feet to the point of beginning.
