ALL that piece, parcel or tract of land in Austin Township, Greenville County, State of South Carolina, being known and designated as Tract No. 3 containing 45.81 acres according to a Survey made by C. O. Riddle of the property of C. C. White Estate, April 1953 and having the following metes and bounds, to-wit:
