WHEREAS I, **Arizona Runyan**

am well and truly indebted to

in the full and just sum of **Two Thousand Five Hundred Sixty and no/100 (\$2,560.00)** Dollars, in and by **MY** certain promissory note in writing of even date herewith, due and payable in **monthly installments of Fifty and no/100 (\$50.00) Dollars per month, including interest, commencing one month from date of execution and on the same day each month thereafter until paid in full, with interest first deducted and balance to principal.**

with interest from **date** at the rate of **six (6%)** per centum per annum until paid; interest to be computed and paid **monthly** and if unpaid when due to bear interest at same rate as principal until paid, and **I** have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That **I**, the said **Arizona Runyan**

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to **me** in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said **Farmers Bank of Simpsonville, its successors and assigns forever:**

All that tract or lot of land in the Town of Simpsonville, Greenville County, State of South Carolina and more particularly described as follows:

BEGINNING at an iron pin on Cox Street, McKinney's corner and running thence with Cox Street, S 75 W, 40 feet to an iron pin; thence N 25 W, 348 feet to a poplar on branch; thence up said branch as the line 69 feet to pin, McKinney's corner; thence with said McKinney's Line, S 20-30 E, 358 feet to the beginning corner.

Also, all that certain piece, parcel or lot of land lying, being and situate in the Town of Simpsonville, County and State aforesaid, the same being lots 0 and 2 of a plat of a survey made by W. J. Riddle, August, 1920, for the partition of the lands of W. C. Abercrombie by the U. S. Realty Auction Company of Knoxville, Tennessee, the same having the following metes and bounds:

BEGINNING at a stake corner of lot No. 4 on Cox Street and running thence along Cox Street, N 75 E, 161.5 feet to an iron pin on South Street; thence along South Street, N. 0-35 E. 184.8 feet to corner of lot No. 3; thence along the line of said lot, S. 89 W. 241 feet to a point on line of lot No. 4; thence along the line of said lot S. 30-30 E. 237 feet to the beginning corner.
