Church Point Lateral

An 8-inch lateral line, 13.48 miles in length, beginning at a tap in the 24-inch Main Louisiana Lateral, in Section 35, Township 7 South, Range 1 West, and extending easterly, past the Sunray Meter Station in Section 77, Township 8 South, Range 2 East, to the Tidewater Meter Station in Section 83, Township 8 South, Range 2 East, all in Acadia Parish, Louisiana. Included in this lateral is a receiving trap at the connection to the 24-inch Main Louisiana Lateral, a sending trap at the Tidewater Meter Station, and a tap connection for the Sunray Meter Station.

Mecom-San Jacinto Lateral

A 16-inch and 12-inch lateral, consisting of 28.83 miles of 16-inch, and 0.14 miles of 12-inch, making a total of 28.97 in length, described as follows: Beginning with 16-inch line on the platform belonging to Medom & San Jacinto Petroleum in Block 45, offshore of Cameron Parish, and extending northerly 7.49 miles to the shore line, in Section 27, Township 15 South, Range 13 West, and continuing northerly to a point in Section 35, Township 11 South, Range 13 West. From this point the 0.14 miles continues to tie in to the existing 12-inch Texas Gas Lateral in the same Section 35, Township 11 South, Range 13 West, all in Cameron Parish, Louisiana. Included in this lateral is a sending trap on the offshore platform; a receiving and sending trap and tie-in to the Mecom separator and meter station at the shore line; a receiving trap at the junction of the 16-inch and 12-inch section; and a tie-in at the junction of the 12-inch section with the 12-inch Texas Gas Lateral.

Union Oil-Live Oak Lateral

A 6-inch lateral of 1.38 miles in length, beginning at the outlet riser of the Union Oil-Live Oak M&R Station, in Section 21, Township 14 South, Range 3 East, and extending northerly to tie-in to the existing 16-inch Live Oak Lateral in the same Section, Township and Range, all in Vermilion Parish, Louisiana.

Southeast Gueydan Lateral

A 4-inch lateral of 3.08 miles in length, beginning at the south property line of the Gueydan Booster Station site in Section 33, Township 11 South, Range 1 West, and extending southerly to tie-in to the facilities of the Pure Oil Company, in Section 16, Township 12 South, Range 1 West; all in Vermilion Parish, Louisiana.

Gueydan Lateral

A 6-inch lateral of 7.06 miles in length, beginning at the outlet riser of the Gueydan Meter and Booster Station, in Section 33, Township 11 South, Range 1 West, and extending easterly to a tap connection in the existing 18-inch Louisiana Main Lateral in Section 27, Township 11 South, Range 1 East, all in Vermilion Parish, Louisiana.

South Clara Driscoll Lateral

A 4-inch lateral of 3.35 miles in length, beginning at the property line of the site of South Clara Driscoll Booster Station, in Part of the George H. Paul Subdivision, and extending easterly to connect to the Petronilla Lateral at Mile Post 7.02, in the George H. Paul Subdivision of the Clara Driscoll Ranch, all in Nueces County, Texas.

Orcones Lateral

A 4-inch lateral of 1.47 miles in length, beginning at the outlet piping of the Orcones Meter Station, in the Heirs of Andres Garcia Survey, Abstract A-657, and extending southerly to a tie-in to the existing Conoco-Driscoll 8-inch lateral at approximate Mile Post 18.93 in the above described Survey, all in Duval County, Texas.

Southeast Rayne Lateral

A 4-inch lateral of 0.90 miles in length, beginning at the outlet piping of the Owen-Southeast Rayne Meter Station, in Section 11, Township 10 South, Range 2 East, and extending south to tie-in to the South Duson 6" lateral at Mile Post 9.43, all in the same Section, Township and Range, Lafayette Parish, Louisiana.

Philadelphia Gas Lateral

A 14-inch lateral of 3.89 miles in length and a dual 10-inch Delaware River Crossing of 0.81 miles in length, described as follows: Beginning at the outlet riser of the Gloucester Regulator Station, Situated at approximate Mile Post 45.28 on the 12" Trenton-Woodbury Lateral, at Greenville and Cypress Avenues, Borough of Bellmar, Camden County, New Jersey, and extending northerly to the east header of the dual 10-inch crossing of the Delaware River, at the west end of Monmouth Street in Camden, New Jersey. The 10-inch dual crossing begins at this header, and extends across the Delaware River, continuing to the site of the Whitman Meter Station on Delaware Avenue, in the City of Philadelphia, Pennsylvania.
