## MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Charles L. Revis and Mary Jane Revis.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Pifty-five Hundred ----DOLLARS (\$ 5500.00 ), with interest thereon from date at the rate of Six (6%)
per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs, Township, on the southwest side of the Buncombe Road, about two miles west of the City of Greer, containing fifty-seven one-hundredths (.57) acres, more or less, and having the following courses and distances, to-wit:

BEGINNING on a nail and cap in the center of the said road at 125 feet S. 33-40 E. from the joint corner of W.W. Dillard, W.P. Dillard and J.S. Paget, and runs thence S. 56-20 W. 20 feet to an iron pin on the western bank of the said road; thence continuing with the same course for a total distance of 200 feet to a stake; thence S. 33-40 E. 125 feet to a stake; thence N. 56-20 E. 200 feet to a nail and cap in the center of the said road (iron pin back on line at 23 feet); thence with the center of the said road, N. 33-40 W. 125 feet to the beginning corner.
