NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in Paris Mountain Township, Greenville County, State of South Carolina, being known and designated as Lot No. 39, as shown on a plat prepared by C. C. Jones & Associates, Engineers, dated April, 1955, entitled "Sharon Park" and recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book EE at page 175, and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Southeastern side of Derwood Lane at the joint front corner of Lots 39 and 40, and running thence with the line of Lot 40, S. 16-30 E. 231.6 feet to an iron pin on the subdivision line; thence with the subdivision line S. 89-49 W. 113.1 feet to an iron pin at the joint rear corner of Lots 38 and 39; thence with the line of Lot 38 N. 10-53 W. 195.4 feet to an iron pin on the Southern side of Derwood Lane; thence with the Southern side of Derwood Lane and following the curve thereof the following chords and distances: N. 74-09 E. 45 feet to an iron pin and N. 65-57 E. 45 feet to the point of beginning.
