To All Whom These Presents May Concern:

SEND GREETINGS:

I, Jewell E. Brooks,

Whereas, I the said Jewell E. Brooks in and by my certain promissory note in writing, of even date with these presents, am (are) well and truly indebted to HOME BUILDING & LOAN ASSOCIATION, Easley, South Carolina, in the full and just sum of Twenty Five Hundred and no/100's Dollars, (\$ 2,500.00) payable at the offices of said Association at Easley, South Carolina, with interest at the rate of Six per centum (6%) per annum, to be repaid in installments of Twenty Five and no/100's \$ 25.00 Dollars, due and payable upon the first day of each and every calendar month hereafter until the full principal sum with interest has been paid, said monthly installment to be applied first to the payment of interest, computed monthly on the unpaid balance, and then to principal; all interest, not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten per cent, besides all costs and expenses of collection, to be added to the amount due on said note and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

, in hand and truly paid by the said HOME BUILDING & LOAN ASSOCIATION, Easley, South Carolina, at and before the signing of these Presents, the receipts whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said HOME BUILDING & LOAN ASSOCIATION, Easley, South Carolina, its successors or assigns:

"ALL that piece, parcel or lot of land in Bates Township, Greenville County, State of South Carolina, lying and situate in Marietta, South Carolina, on the eastern side of right of way of Greenville & Northern Railway and having the following metes and bounds: BEGINNING at an iron pin on the right of way of G & N Railroad and running thence N 89 E 209.6 feet to an iron pin, joint corner of P. D. Jarrard and W. H. Jarrard; thence N 00-15 W 80 feet to an iron pin on the Hart Estate line; thence N 85-15 W 210 feet with Hart Estate line to an iron pin on right of way of G & N Railroad; thence with said right of way S 00-15 E 91.6 feet to the BEGINNING corner; being the same land conveyed to B. C. Gravely by Jewell E. Brooks by deed dated February 27, 1956, recorded in Book of Deeds , at page , and being the same land conveyed to Jewell E. Brooks by B. C. Gravely by deed dated June 6, 1958, recorded in Book of Deeds , at page , in the office of the Clerk of Court for Greenville Co., South Carolina."

TOGETHER with, all and singular, the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the Premises before mentioned unto the said HOME BUILDING & LOAN ASSOCIATION, its Successors or Assigns forever. And I (we) do hereby bind myself (ourselves), my (our) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the said HOME BUILDING & LOAN ASSOCIATION, its Successors or Assigns, from and against myself (ourselves), my (our) Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming or to claim the name or any part thereof.
