Louis E. Howard (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Southern side of Cole Road, and being known and designated as Lot 7 on a plat of the property of W. H. Brown, made by C. C. Jones, recorded in Plat Book 00 at page 117, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Cole Road, at the joint front corners of Lots 6 and 7; thence with the line of Lot 6, S. 14-05 E. 345.6 feet to a pin; thence N. 77-18 E. 65 feet to a pin at rear corner of Lot 8; thence with the line of Lot 8, N. 10-03 W. 324.6 feet to pin on Cole Road; thence with the South side of Cole road, N. 86-49 W. 80 feet to the point of beginning.

Being the same property conveyed to Mortgagor by deed of W. H. Brown of even date, to be recorded herewith.
