"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs, Township, on the east side of the Suber Road and on Princess Creek, about three miles southwestward from the City of Greer, containing 9.20 acres, more or less, and being a portion of the W.A. Smith tract as shown on a plat of the Charles Miller Estate by H.S. Brockman, Surveyor, dated September 10, 1938, and having the following courses and distances, to-wit:
