"All that piece, parcel or lot of land in Greenville Township, Greenvills County, State of South Carolina, known and designated as lot Number 49, of Section #2, as shown on a plat of Victor Monagham Mills recorded in Plat Book "S" at pages 179-181, and being more particularly described according to a recent survey prepared by J. C. Hill, June 2, 1950, as
