C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, lying south of Ikes Road, being shown and designated as Tract number three (No. 3) on a plat of the property of Vivan Howell, made by C.
