All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, known as Lot # 2 of a subdivision as Forest Park, plat recorded in Plat Book EE at pages 64 and 65. This property was formerly known as Gresham Park. A partial plat is recorded in the R. M. C. Office for Greenville County in Plat Book BB at pages 70-71.

The foregoing lot was conveyed to mortgagors by deed of Simpsonville Lumber & Supply Company, Inc., August 5, 1958, to be recorded.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
