recorded in the R.M.C. Office for Greenville County, S.C., in Plat Book
"KK", at page 93, said lot fronting 62 feet along the North side of
Jasmine Drive, and running back to a depth of 150 feet on the East side,
to a depth of 150 feet on the West side, and being 62 feet across the
rear.
