WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Thirty-Five Hundred and No/100------

per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

being known and designated as A Part of lots # 1 and 2, on a plat of property of Hillside Heights, prepared by R.E. Dalton dated September 1921, recorded in Plat Book F at Page 100 in the RMC Office for Greenville County, and described as follows:

BEGINNING at a stake on the Western side of Brookside Avenue (sometimes called Circle Street), at the corner of property now or formerly of R. R. Ray, and running thence with the line of said property, S. 45-11 W. 98.75 feet to a stake; thence S. 77-00 W. 49.6 feet to a stake in line of lot # 14; thence with the line of said lot and continuing with line of lot # 13, S. 27-42 E. 55 feet to a stake; thence N. 55-30 E. 159 feet to a stake on Brookside Avenue; thence with said Avenue, N. 44-19W. 55 feet to the point of beginning.

Being the same premises conveyed to the mortgagors by John L. Drake by deed recorded in Volume 419 at Page 31.
